- ❖ I agree to pay the \$50.00 per family non-refundable registration fee.
- ❖ I agree to make all scheduled tuition payments on time and to pay the total tuition as calculated.
- ❖ I understand that my registration will not be considered complete until my 2009-10 tuition is paid in full.
- ❖ I understand that in the event my tuition account becomes 60 days past due my child/children may be excluded from classes until the account is current or arrangements to pay have been made with the parish office.
- ❖ I understand that if my grant status changes, I am liable for the full tuition amount.
- ❖ I understand that I must complete 30 hours of volunteer service to the school (10 hours = \$100) or pay the \$300.
- ❖ EdChoice Scholarship: I understand I am responsible for tuition hours not paid by the EdChoice Scholarship. I must volunteer beyond the 30 hours required of everyone or pay the difference (10 hours = \$100). The 30 hours stated above is counted toward the amount due.
- ❖ As a Catholic, participating family, I understand it is my responsibility to have my pastor sign before returning this registration form to the school.
